SUPPLEMENTARY REGULATIONS

- JURISDICTION:** Held under the National Sporting Code of the ACU, ACU Standing Regulations for Shorttrack, these Supplementary Regulations and any instructions that may be issued.
- ELIGIBILITY:** All riders must hold a current ACU Competition Licence or International Licence issued by the ACU, SACU, or the MCU of Ireland. If a one-day licence is required, proof of identity **MUST BE** produced. (Driving Licence/Passport etc)
- ENTRIES:** To be sent to the Secretary of the meeting on the official entry form with the correct fee; Shorttrack UK Members £35, X-plate riders £35. **Please include S.A.E. Entries close 12th Aug.** Please make cheques payable to Shorttrack UK Ltd. In the case of a 'rain-off', if practice has taken place half the entry fee will be returned, if racing has started there will be no refund. Championship points will only be awarded if the meeting is completed.
- TECHNICAL CONTROL** of machines, clothing and helmets must be completed before Official Practice begins. Technical control and signing on will start at **9.00am** and finish at **10.30am**.
- PRACTICE** will commence at **11.00am. NO ENGINES TO BE STARTED BEFORE 10.45am.**
- RACE START TIME : 1.00pm.**
- FLAG SIGNALS:** As Standing Regulations. **ANY DRIVER IGNORING FLAG SIGNALS WILL BE EXCLUDED FROM THE MEETING, IT IS VITAL THAT MARSHALLS, FIRST-AID CREWS AND FALLEN RIDERS RECEIVE THEIR PROTECTION.**
- COURSE** Length approximately 342m.
- METHOD OF START:** Start gate or flag in event of failure.
- AWARDS:** Trophies
- INSURANCE COVER** for this event will be Basic (limit of liability £10m), with medical malpractice insurance included. There is **NO** Personal Accident Insurance for Competitors.
